| <p>1.) Please use common sense. If an action seems inappropriate, it most likely is.</p> <p>2.) A copy of the permit must be available at the Field for inspection during the use. It is the responsibility of the organizer or person to make sure coaches receive and understand that permits must be on site during the Field use.</p> <p>3.) Field use begins and ends at the times stated on the permit, including set-up, warm-up, and clean up. Organizations are not allowed on the Field prior to the start time in the permit and are required to exit the Fields and have adjacent areas (such as benches, dugouts, and so forth cleaned up at the ending time indicated on the permit.</p> <p>4.) All litter must be picked up and either taken home or placed in trash cans after each use.</p> <p>5.) Permits are non-transferable. All permit holders will ensure that no unauthorized party is granted permission to use the Field during the permitted times.</p> <p>6.) Parking is allowed in designated areas only. Vehicles (other than emergency vehicles) are not allowed on Field. Vehicles include both motorized (e.g., cars, trucks, motorcycles, and non-motorized vehicles).</p> <p>7.) Alcohol is prohibited on the Fields or adjacent areas, such as announcer's booth, bleachers, bathrooms, concession stand, dugouts, and Borough parking lots, unless such use is specifically permitted by the Borough in writing.</p> <p>8.) Use of tobacco products (including cigarettes, cigars, and chewing tobacco) is prohibited on the Field or adjacent areas, such as announcer's booth, bleachers, bathrooms, concession stand, dugouts, and Borough parking lots.</p> <p>9.) Use of illegal drugs and other controlled substances is prohibited on the Field or adjacent areas, such as announcer's booth, bleachers, bathrooms, concession stand, dugouts, and Borough parking lots.</p> <p>10.) Animals (except service animals) are prohibited on the Fields or adjacent areas, such as announcer's booth, bleachers, bathrooms, concession stand, dugouts, and Borough parking lots.</p> | <p>11.) Glass bottles are prohibited on the Field or adjacent areas, such as announcer's booth, bleachers, bathrooms, concession stand, dugouts, and Borough parking lots.</p> <p>12.) No vandalism is allowed on the Field or adjacent areas, such as announcer's booth, bleachers, bathrooms, concession stand, dugouts, and Borough parking lots.</p> <p>13.) No climbing on fences, backstops, goals, baskets, or other equipment is allowed.</p> <p>14.) No profanity is allowed on the Field or adjacent areas, such as announcer's booth, bleachers, bathrooms, concession stand, dugouts, and Borough parking lots.</p> <p>15.) Fighting or verbal or physical harassment is prohibited on Field or adjacent areas, such as announcer's booth, bathrooms, bleachers, concession stand, dugouts, and Borough parking lots.</p> <p>16.) Activities which might damage the Field are prohibited, including, but not limited to, golf, horseshoes, javelin, shot put, lawn darts and grilling.</p> <p>17.) Fireworks are prohibited on the Field or adjacent areas, such as announcer's booth, bathrooms, bleachers, concession stand, dugouts, and Borough parking lots.</p> <p>18.) Selling food, drink or other items is prohibited without the approval of the Borough</p> <p>19.) Adult supervision of youth players and participants is required for games and practices. A youth team is not allowed to practice or play on a Field absent adult supervision.</p> <p>20.) Permit users must abide by posted hours and other posted requirements and are responsible for the conduct of their guests.</p> <p>21.) Permit users must comply with all Borough ordinances, as well as the laws and regulations of the Commonwealth of Pennsylvania and the United States.</p> |

The Borough reserves the right to revoke or suspend Field Permits for games and other usages based upon Field users violating this guide or Borough ordinances, or when it is in the best interests of the Borough. The Borough may use a "Three Strikes" policy with respect to violations, although the Borough specifically reserves the right to suspend or revoke a permit at any time, or to deny a request for a permit, regardless of the number of violations which precede that decision.

The undersigned hereby makes application for use of the field/facility and agrees to abide by the rules and regulations stated above or otherwise applicable. This is a conditional permit application for temporary use of a West Homestead Borough Field. The permit, if granted, is for use of the designated field only for the days and times listed. You and your organization are obligated to keep the field in good and safe condition at all times and to use the field only in accordance with the listed purpose. Any problems with the field or Borough Facilities are to be reported to the Borough within 24 hours. The applicant, on behalf of himself and the organization represented by the applicant agrees to hold the Borough of West Homestead free and harmless from liability of any nature, and knowingly and freely assumes all risks, known and unknown related to use of the field/facility, and further assumes all responsibility for such use.
